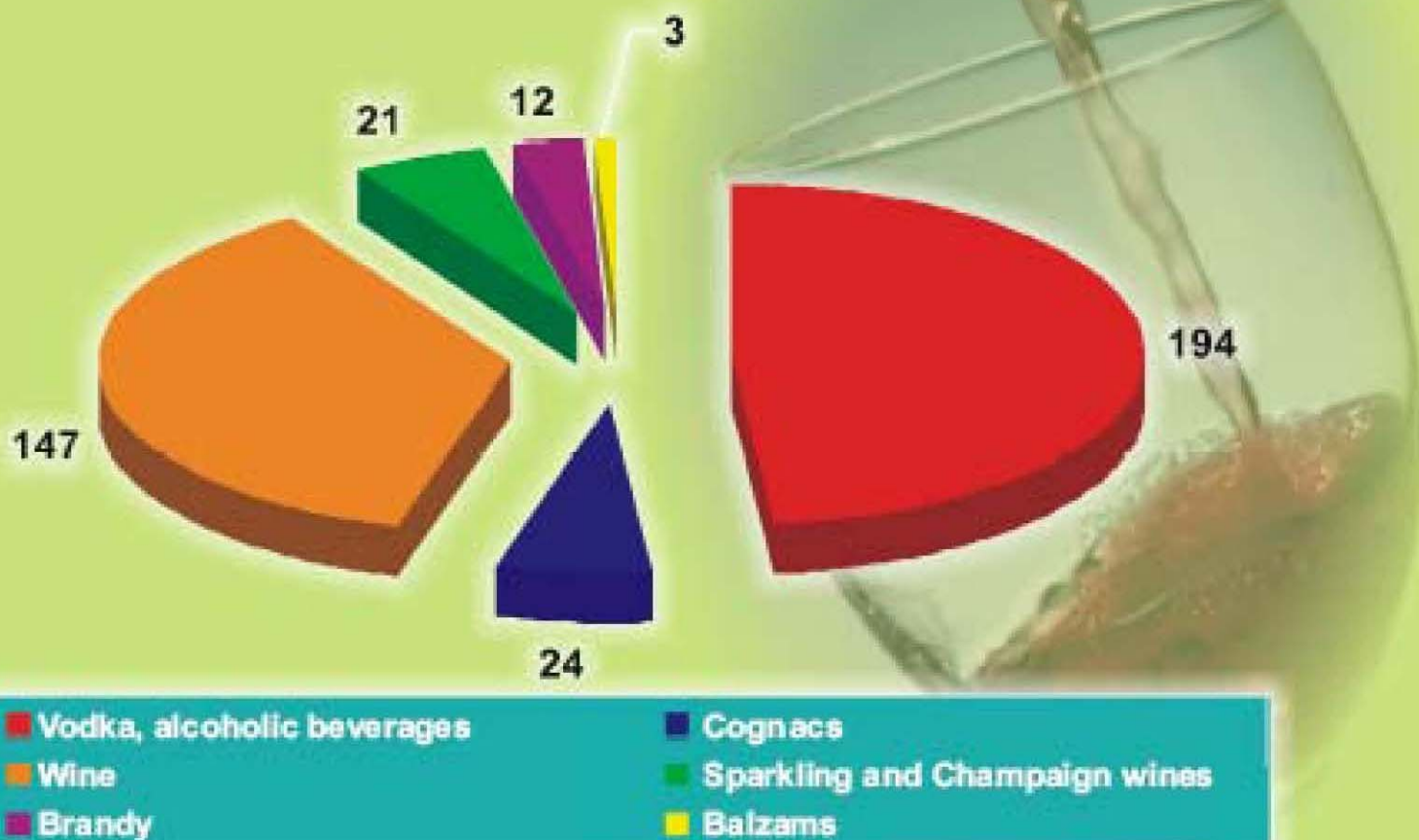

- Wide attraction of foreign investments to the industry, rendering assistance in establishment joint ventures with foreign investments.



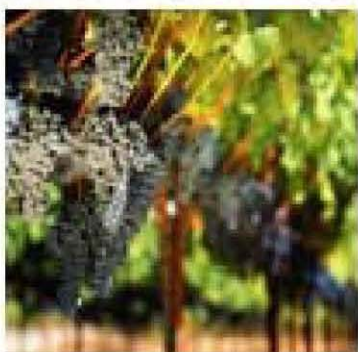

➤ Nowadays 37 sorts of wine are divided by districts and cultivated. They take the area of more than 118 thousand hectares.

21 types of Champaign and sparkling wines;

24 types of cognacs;

200 types of alcoholic beverages;

163 fortified, dry, vintage and sweet wines.

➤ Completion of the project, will give an opportunity for companies to extend of export of finished products in various types and capacity glass bottles of own production meeting the international requirements.

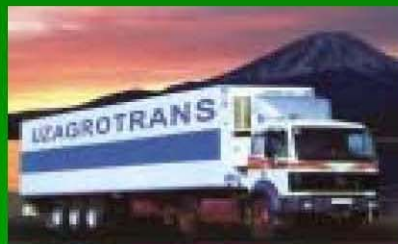

Products are also exported to Ukraine, Malaysia, Afghanistan, Tajikistan, Mongolia and Turkmenistan.



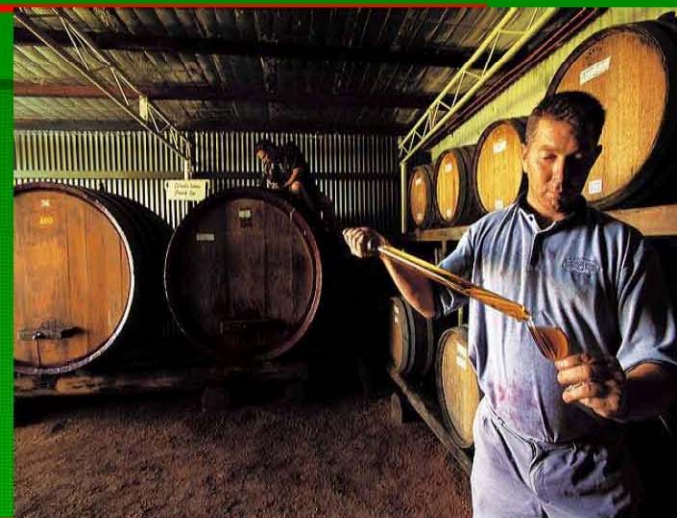

- stabilizing agents.

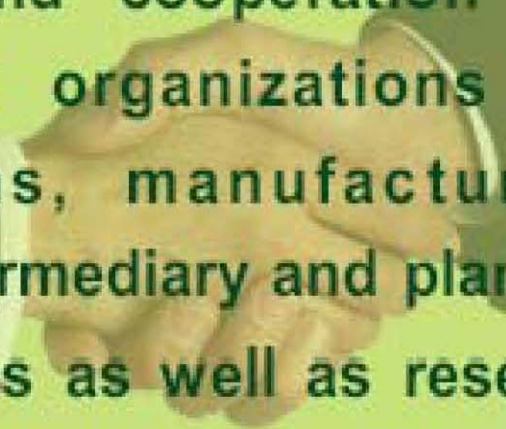

Investment offers of “Uzvinprom-Holding” on cooperation with the Korean partners



- Preliminary grape processing line for obtaining high quality dry and champagne wine materials, the output of which is 10-20 tons per hour in the set.

- Table wine bottling line, the output of which is from 3 to 6 bottles/hour in the set.

- Distillation plant of Sharatan type UPKS for the output of high quality brandy alcohol in the set.



➤ Membrane filtration manifold for wine;

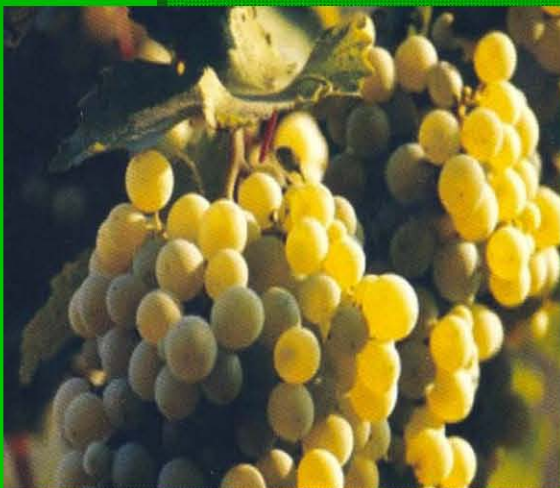
➤ Filtration manifold for vodka production;

➤ Vodka bottling line, the output of which is from 6 thousand bottles/hour in the set;



➤ Purchasing of oaken barrels, the capacity of which is 350-500l;

➤ A set of laboratory equipment for the determination of physical & chemical figures of alcohol, vodka, wine, brandy & champagne wines;



➤ Centrifuges for winemaking;

➤ Pasteurizing and cooling plant for wine;

➤ Automatic capping cork stopper machine for bottles, the output of which is 3-6 thousand bottles per hour;

It is the only one enterprise in Ferghana region specialized in vodka and grape wines making. Rich resources of grapes in the region allow increasing grape wines production intended for the CIS countries, mainly Russian Federation.

1. It would be expedient to provide financial support to the enterprise aimed at modernization and technical retooling of the production processes and supply of the plant by the basic accessory materials including oaken barrels for vintage wines making.

2. To mount vodka bottling line with the output of 6 thousand bottles/hour in the set amounting to USD 200 thousand for vodka making.

OJSC «Kukonspirt»

1. For series manufacture of the brand "Lux" alcohol to purchase a set of Brago retificate installation (BRI) equipment and additional columns for final purification amounting to USD 700 thousand.

2. For making of the ecologically pure product to purchase equipment for carbon-dioxide station modernization amounting to USD 300 thousand.

3. It is offered for sale to the foreign investors 47% of the non-allocated shares of the enterprise at the amount approximately USD 3800 thousand.
